

SOFTWARE LICENSE AGREEMENT
ZC4, ZCP Complete Classification
OF
H.N.M. DIJKEMA, HOMEOPATHIE NEDERLAND B.V.

IMPORTANT - READ THIS CAREFULLY

You are expected to read this Agreement before proceeding to install ZC4, ZCP Complete Classification.

This License Agreement ("Agreement") is an agreement between you (an individual or legal entity) and the author of ZC4/ZCP Complete Classification, H.N.M. Dijkema; Homeopathy Nederland B.V., for ZC4/ZCP Complete Classification provided with this Agreement. The Software may be accompanied by a supplement or amendment to this Agreement, as appropriate.

By installing, copying or using the Software, you agree to be bound by the terms of this Agreement. If you do not agree to this Agreement, do not install, copy or use this software. In that case, you may return the software to the place of purchase (if applicable) for a full refund based on proof of purchase.

- 1 GRANT OF LICENSE. H.N.M. Dijkema, Homeopathy Nederland B.V. grants you the following rights, subject to your compliance with all the terms and conditions of this Agreement.
 - 1.1 Installation and Use. You may: (a) install a copy of the Software on your computer. (b) back up the installation software.
 - 1.2 Licensing of Remote Desktop. You may use remote access technology, such as the Remote Desktop features in Microsoft Windows, VNC Sessions on Linux or Mac OS systems, to access and use your licensed copy of the Software, provided that only the first user of the device on which the remote desktop session is conducted may access and use the Software through a remote device. Remote desktop use rights do not mean that you may simultaneously use the Software on both the remote device and the device on which the remote desktop session is running.
 - 1.3 Licensing of Remote Support. You may grant any device access to and use of your licensed copy of the Software when access and use are for the sole purpose of providing you with technical support and maintenance services.

- 4 RESTRICTION ON REVERSE ENGINEERING, DECOMPILATION AND DISASSEMBLY. You may not reverse engineer, decompile or disassemble the Software, except if and to the extent that, notwithstanding this restriction, such activity is expressly permitted under applicable law.
- 5 NO RENTAL/COMMERCIAL HOSTING. You may not rent, lease, lend, or provide commercial hosting services with the Software.
- 6 CONSENT TO USE OF DATA. You agree that H.N.M. Dijkema, Homeopathy Nederland B.V. may collect and use technical data collected as part of the support services provided to you that relate to the Software. H.N.M. Dijkema, Homeopathy Nederland B.V. may use this data solely for the purpose of improving its products or providing you with customized services. These data will not be disclosed in a way that would reveal your identity. See also 2.1.

- 9 UPGRADES. H.N.M. Dijkema, Homeopathy Nederland B.V. can provide upgrades for minor versions of ZC4/ZCP Complete Classification. ZC4/ZCP Complete Classification has a version number with 2 digits: x.y. Software of version x constitutes a major version. Versions x.y constitute minor versions. Increases in versions x imply a new release of ZC4/ZCP Complete Classification and are not upgrades. They require the purchase of a new license. Upgrades do not require the purchase of a new license.
 - 9.1 Before you can use upgrade Software, you must first have a license for the software designated by H.N.M. Dijkema as the basis for the upgrade. After installation of the upgrade, the original software that served as the basis for the upgrade may only be used as part of the updated software.
 - 9.2 Software that is not upgraded will continue to be supported for up to 3 months.
 - 9.3 Old release of the software are still supported for up to 6 months.
- 10 SEPARATION OF COMPONENTS. The Software is licensed as a single product. Its components may not be separated for use on more than one device.
- 11 SOFTWARE TRANSFER. The license to this software is bound to you. Transfer of the software can be done in consultation with the author, H.N.M. Dijkema, Homeopathy Nederland B.V.. Your license will then be revoked and the person to whom the software is transferred will receive a new license. The person to whom the software is transferred has to agree with these terms and conditions in writing, just like you.
